- -Received Square Dancers contract. Motion made by Amanda Lantz to pay \$350 for Square Dancers in Red Barn Thursday night of fair, motion was seconded by Jim Bly, motion carried and passed.
- -David Dick spoke about insurance costs and other agencies, discission. Motion made by Kim Moore to let executive committee decide on insurance company to go with, motion was seconded by Remington Blevins, motion carried and passed.
- -Discussion on David Yoder helping with website, social media and promotions. Amanda Lantz made a motion to accept David Yoder helping with our Website, social media and promotions, motion was seconded by Dave Grauer, motion carried and passed.
